BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager be and he is hereby authorized and empowered to pay the sum of \$77,722.54 in the settlement of each and every claim against the City of San Diego, its agents and employees, in Superior Court Case No. GIC 751861, *John Garcia v. City of San Diego*, resulting from personal injury to Plaintiff, a forty-four year-old, Hispanic, male water utility worker. In his lawsuit, he alleges race, gender, age, and disability discrimination, and retaliation in the promotional examination process for Water Utility Supervisor (WUS).

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue a check in the amount of \$65,000.00, made payable to plaintiff and attorney of record in full settlement of all claims, and another check in the amount of \$12,722.54 to plaintiff for back pay.
