WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of public service easements by City Council resolution where the easement has been superceded by relocation and there are no other public facilities located within the easement; and

WHEREAS, the affected property owner has requested the vacation of a flood water storage easement in Parcel 1 of Parcel Map 15238 and flood water storage, drainage and slope easements in Parcel 1 of Parcel Map 18224 to unencumber this property and facilitate development of the site; and

WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the easements either for which they were originally acquired, or for any other public use of a like nature that can be anticipated; and
 - (b) the public will benefit from the vacation through improved utilization of land; and
- (c) the vacation is not inconsistent with the General Plan, an approved Community Plan. or Local Coastal Program; and
- (d) the public service easements for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the flood water storage easement located within parcel Map 15238, and the flood water storage, drainage and slope easements located within Parcel Map 18224, as more

particularly described in the legal description marked Exhibit "A" and shown on drawing No. 19505-1-B, marked Exhibit "B", attached hereto and by this reference made a part hereof, are ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with attachments, attested by him under seal, to be recorded in the office of the County Recorder.


