WHEREAS, in 1999 the Environmental Services Department, along with the California Integrated Waste Management Board [CIWMB] began investigating the extent of burn ash contamination; and

WHEREAS, in early 2000, the Environmental Services Department retained the services of an engineering consultant to complete the assessment, and this assessment found contaminated soils extended onto eight residential properties, the City's vacant lot and Cal Trans easement along Highway 15; and

WHEREAS, in November 2000, EPA performed and completed the removal and disposal of the top 3-feet of contaminated soil and backfilled the excavation with clean soil material; and

WHEREAS, on February 1, 2000, by Resolution No. R-292710, the Council of the City of San Diego approved an application to the CIWMB for matching grant funds; and

WHEREAS, on June 19, 2001, CIWMB awarded a matching grant not to exceed \$750,000 for expenditures related to the 38th and Redwood Streets Burn Site Project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the City Manager, or designee, is authorized, for and on behalf of the City, to accept a matching grant from the California Integrated Waste Management Board for the 38th and Redwood Street Burn Site project.

2. That grant funds up to \$750,000 is hereby authorized to be appropriated in and expended from CIP 32-0100 (Annual Allocation - Unclassified Disposal Sites), contingent upon receipt of funds.
