BE IT FURTHER RESOLVED, that a portion of Corporate Center Drive per Map No. 13882, Ocean View Hills Corporate Center Unit No. 1, not shown within the boundary of this MAP was closed and vacated pursuant to the provision of Section 66434(g) of the Subdivision Map Act.

BE IT FURTHER RESOLVED, that the Council accepts on behalf of the City of San Diego, the easement with the right of ingress and egress for construction and maintenance of water facilities designated as "Water Easement Granted Hereon", as granted and shown on the MAP and subject to the conditions set forth on the MAP.

BE IT FURTHER RESOLVED, that the Council accepts on behalf of the City of San Diego, a limited avigation and height restriction easement and right-of-way designated as "Avigation Easement Granted Hereon", as granted and shown on the MAP and subject to the conditions set forth on the MAP.

BE IT FURTHER RESOLVED, that the Clerk of the City is authorized and directed to endorse upon the MAP, as and for the act of the Council, that the Council has approved the MAP, and that the streets are accepted on behalf of the public as stated in this resolution.
