
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, the First Amendment to the Agreement with Earth Tech to provide professional services for final environmental report and conceptual design of El Camino Real between Via De La Valle and San Dieguito Road, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 295346.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to reprogram an amount not to exceed \$90,137 from Fund 30300, CIP 52-519.0, Bridge Rails-Citywide, to CIP 52-479.0, El Camino Real-Half Mile Drive to Via De La Valle.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$450,684 of which \$360,547 is from Fund 38728, and \$90,137 is from Fund 30300,

CIP 52-479.0, El Camino Real - Half Mile Drive to Via De La Valle, is hereby authorized, solely and exclusively for the purpose of providing funds for the first amendment to the agreement.
