A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A SECOND AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT AND EXPENDITURE OF GRANT FUNDS FOR WINTERWOOD LANE COMMUNITY PARK

WHEREAS, on July 19, 1990, the City of San Diego entered into an agreement with Marum Associates, now Wimmer Yamada and Caughey, for professional design services necessary for development of Winterwood Lane Community Park; and

WHEREAS, on May 27, 1997 the City entered into a First Amendment to Agreement to expand the scope of professional services to include preparation of construction documents for the adjacent joint-use ballfields at Challenger Middle School; and

WHEREAS, the City desires to further amend the agreement to provide the environmental review necessary to complete development of the Park; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Council approves and authorizes the City Manager to execute, for and on behalf of City, a Second Amendment to Consultant Agreement with Wimmer Yamada and Caughey, for the professional services required for CIP No.29-727.0, Winterwood Land Community Park - Development, Phase II, upon substantially the terms and conditions set forth

in the Agreement on file in the office of the City Clerk as Document No. RR- 295343, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

- 2. That the Council authorizes the Auditor and Comptroller to reprogram \$123,181.89 from CIP 29-716.0, WINTERWOOD LANE COMMUNITY PARK ACQUISITION AND DEVELOPMENT (PHASE I), to CIP No. 29-727.0, WINTERWOOD LANE COMMUNITY PARK –DEVELOPMENT, PHASE II in Fund No. 79006, Mira Mesa FBA; and
- 3. That the Council authorizes the Auditor and Comptroller to amend the Fiscal Year 2002 CIP Budget by increasing the appropriation of CIP No. 29-727.0 by \$123,181.89 in Fund No. 79006, Mira Mesa FBA; and
- 4. That the Council authorizes the City Manager to execute the Second Amendment to the Agreement with Wimmer Yamada and Caughey in the amount of \$100,845 for expanded professional services; and
- 5. That the Council authorizes the expenditure of an amount not to exceed \$100,845 from CIP No. 29-727.0, Winterwood Lane Community Park Development, Phase II, Fund No. 79006, Mira Mesa FBA for the Second Amendment to the Consultant Agreement with Wimmer Yamada and Caughey; and
- 6. That the Council authorizes the City Manager to transfer and expend all remaining funds from CIP fund number 29-716.0, Winterwood Lane Community Park Acquisition and

Development (Phase I), to CIP fund number 29-727.0, Winterwood Lane Community Park - Development (Phase II).
