BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Fiscal Year 2002 Capital Improvements Program Budget is hereby amended by increasing CIP No. 62-275.0, Traffic Signals - FBA/PDIF Fund, in an amount not to exceed \$50,000.
2. That the appropriation and expenditure of an amount not to exceed \$50,000 from Fund 63022, Private and Other Contribution - CIP, to CIP No. 62-275.0, Traffic Signals - FBA/PDIF Fund, for the purpose of funding the construction of a Traffic Signal and Street Lighting System at Carmel Country Road and Caminito Clasica, is hereby authorized.
3. That the City Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
