BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Pepita Way, as more particularly described in the legal description, marked Exhibit "A", and as shown on Drawing No. 19501-B, marked Exhibit "B", which are attached hereto and by this reference made a part hereof, is ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution with attachment, attested by him under seal, to be recorded in the office of the County Recorder.
