BE IT FURTHER RESOLVED, that the appropriation and expenditure of an amount not to exceed \$183,000 from CIP 63-039.0, Fund 38664 is hereby authorized for the purpose of funding the construction of the Centre City Motorist Information System, contingent upon receipt of a fully executed Program Supplement.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller, upon advice from the administering department, is hereby authorized to transfer excess funds, if any, to the appropriate reserves.
