WHEREAS, it is desirable that this Special Municipal Election be consolidated with the Statewide Primary Election to be held on the same date; and

WHEREAS, it is desirable that within the City of San Diego the election precincts, polling places, voting booths and election officials for the elections be the same; and

WHEREAS, it is desirable that the Registrar of Voters of the County of San Diego be authorized to canvass the returns of the Special Municipal Election; and

WHEREAS, it is desirable that this Special Municipal Election and the Statewide Primary Election be held in all respects as if there were only one election; and WHEREAS, in the year 2002 the Statewide Primary Election will be held on the 5th day of March; and

WHEREAS, this Council within the time required by law has adopted or will adopt an ordinance calling for a Special Municipal Election; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. The Board of Supervisors for the County of San Diego is hereby requested to consolidate the Special Municipal Election to be held in the City of San Diego on March 5, 2002, with the Statewide Primary Election to be held on the same date.

BE IT FURTHER RESOLVED, that the City of San Diego agrees to indemnify and to save free and harmless the County, its officers, agents and employees from expense or liability, including reasonable attorney fees, as a result of an election contest initiated pursuant to the provisions of California Elections Code sections 16000 through 16900.
