BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$200,000 from Fund 30300, CIP 52-690.0, Fay Avenue Realignment, and an amount not to exceed \$34,235.22 from Water Fund 41500, CIP 70-953.0, Torrey Pines Road/La Jolla Boulevard Main Replacement, and an amount not to exceed \$5,000 from Sewer Fund 41506, CIP 44-001.0, Annual Allocation for Sewer Mains, is authorized solely for the purpose of the additional storm drain, water and sewer construction, engineering, city force work and related City obligations.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves, provided that the City Auditor first furnishes a certificate demonstrating that the funds necessary for such expenditures is, or will be, on deposit in the City Treasury.
