
WHEREAS, the 303 Coast Boulevard Storm Drain Project will provide for replacing approximately 200 linear feet of undersized 10-inch concrete storm drain pipe and inlet in the Scripps Lane alley and across private property with an 18-inch reinforced concrete storm drain pipe in a new drainage easement. This project will eliminate the frequent flooding of the Scripps Lane alley and the private property at 303 Coast Boulevard; and

WHEREAS, the new drainage easement is required to relocate the drainage pipe from under the condominium building located at 265 Coast Boulevard and to increase the size of the pipe to 18-inches; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the City Manager, or his designee, is hereby authorized to acquire said property rights for drainage easement purposes.
2. That the expenditure of not to exceed \$90,000 from CIP 11-301.0 (Fund No. 79514) for the acquisition of property rights, appraisal, labor, title, escrow, and miscellaneous costs, is authorized and approved.


