- 2. That the City Manager is hereby directed to negotiate and execute, for and on behalf of said City, an agreement with Serra High School Foundation, to contribute said funds to assist in their roadside improvements, and to incorporate into the agreement with Serra High School Foundation, that there be no ongoing fiscal impact to City to improve or maintain the parcel; that Tierrasanta Maintenance Assessment District will absorb into their budget the cost of maintenance with no additional assessment to residents.
