WHEREAS, the turfed fields and parking lots at Wangenheim Middle School are the subject of a joint use agreement between the City of San Diego and the San Diego Unified School District; and

'WHEREAS, the City desires to light the fields for night play to expand the community's recreational opportunities; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Council authorizes amendment of the Fiscal Year 2002 Capital Improvements Program by adding CIP No. 29-508.0, Wangenheim Middle School Sports Field Lighting, in the amount of \$258,000.
- 2. That the Council authorizes the City Auditor and Comptroller to reprogram \$100,000 in Fund No. 79006 from CIP No. 29-404.0, Lopez Ridge Neighborhood Park Development, to CIP No. 29-508.0, Wangenheim Middle School Sports Field Lighting.
- 3. That the Council appropriates, and authorizes the City Auditor and Comptroller to expend \$258,000 for lighting the turfed fields at Wangenheim Middle School (CIP No.29-508.0) from the following funds: \$100,000 from Fund No. 79006, Mira Mesa Facilities Benefits Assessment (CIP No. 29-404.0, Lopez Ridge Neighborhood Park Development); \$150,000

from Fund No. 79006, Mira Mesa Facilities Benefits Assessment; and \$8,000 from Fund No.

11220, Park Service District - Mira Mesa East - Major District.
