A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO RATIFYING THE ELECTION RESULTS OF NOVEMBER 19, 2001, FOR THE CITY HEIGHTS REDEVELOPMENT PROJECT, PROJECT AREA COMMITTEE.

WHEREAS, on September 14, 1999, the Council of the City of San Diego [Council], by Resolution No. R-292185 [amended July 9, 2001], adopted the Procedure of the Formation of a Project Area Committee [PAC] for the City Heights Redevelopment Project [Project]; and

WHEREAS, on May 1, 2001, the Council by Resolution No. R-294800 amended the Procedure for Formation of a PAC for the City Heights Redevelopment Area; and

WHEREAS, a representative from the City Clerk's office attended the November 19, 2001, election to ensure its validity; and

WHEREAS, California Community Redevelopment law [Law] requires that a PAC remain in existence for three years from the date of adoption of the redevelopment plan; and

WHEREAS, the elected members of the PAC have submitted to the Council, information establishing the qualifications of each person relative to district, category or organization as appropriate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the City Heights Redevelopment Project Area Committee consisting of persons named on the list of PAC members receiving the highest number of votes, attached hereto as Exhibit A and incorporated herein by this reference, is hereby approved as constituting a representative PAC.

2. That the Council hereby concurs that the election results of November 19, 2001, are valid and binding in accordance with the procedures so adopted by Resolution Nos. R-292185 and R-294800.

3. That the Project PAC be extended for a period of one year from the date of this resolution.
