WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of public street easements by City Council resolution where the easement is no longer required; and

WHEREAS, the affected property owner has requested the vacation of a portion of Kate Sessions Way, to facilitate development of the site; and

WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the public street system, either for which the right-of-way was originally acquired, or for any other public use of a like nature that can be anticipated in that the right-of-way is not needed for public street, bikeway, or open space purposes; and
 - (b) the public will benefit from the vacation through improved utilization of land; and
- (c) the vacation is not inconsistent with the General Plan or an approved Community Plan; and
- (d) the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the street vacation, as more particularly described in the legal description marked as Exhibit "A" and as shown on Drawing No. 19348-B marked as Exhibit "B", attached hereto and made a part hereof, is ordered vacated.

- 2. This resolution shall not become effective unless and until the applicant improves the remainder of the right-of-way with asphalt paving and berm as required by the City Engineer within a period of twenty four months after the adoption of this resolution.
- 3. In the event the above condition is not completed within two years following the adoption of this resolution, then this resolution shall become void and be of no further force or effect. The City Engineer shall advise the City Clerk of the completion of the aforementioned condition and the City Clerk shall then cause a certified copy of this resolution with attached exhibits, attested by him under seal, to be recorded in the office of the County Recorder.



LEGAL DESCRIPTION STREET VACATION

BEGINNING AT THE MOST EASTERLY NORTHEAST CORNER OF LOT 9 OF SAID MAP NO. 1618, ALSO BEING A POINT ON THE SOUTHERLY AND SOUTHWESTERLY LINE OF SAID KATE SESSIONS WAY AS DEDICATED ON SAID MAP, SAID POINT BEING ON A CURVE CONCAVE NORTHERLY; THENCE WESTERLY AND NORTHWESTERLY ALONG SAID CURVE, BEING THE SOUTHERLY AND SOUTHWESTERLY LINE OF KATE SESSIONS WAY AND THE NORTHERLY AND NORTHEASTERLY LINE OF SAID LOT 9 TO A POINT ON THE SOUTHEASTERLY LINE OF LOS ALTOS ROAD AS DEDICATED ON SAID MAP. ALSO BEING THE MOST NORTHERLY NORTHEAST CORNER OF SAID LOT 9: THENCE NORTHEASTERLY ALONG THE NORTHEASTERLY PROLONGATION OF SAID SOUTHEASTERLY LINE OF LOS ALTOS ROAD TO A POINT ON A LINE LYING PARALLEL WITH AND 15.00 FEET NORTHERLY AND NORTHEASTERLY OF SAID SOUTHERLY AND SOUTHWESTERLY LINE OF KATE SESSIONS WAY: THENCE SOUTHEASTERLY AND EASTERLY ALONG SAID PARALLEL LINE TO THE NORTHERLY PROLONGATION OF THE EASTERLY LINE OF SAID LOT 9; THENCE SOUTHERLY ALONG SAID NORTHERLY PROLONGATION TO THE POINT OF BEGINNING.
