

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A TEN YEAR AGREEMENT FOR THE JOINT USE, OPERATION, AND MAINTENANCE OF TURFED FIELDS, PARKING LOT, AND RESTROOM AT ADOBE BLUFFS ELEMENTARY SCHOOL AND ADOBE BLUFFS PARK WITH THE POWAY UNIFIED SCHOOL DISTRICT; ADDING CIP 29-570.0, ADOBE BLUFFS - JOINT USE AREA IMPROVEMENTS, TO THE FY 2002 CIP BUDGET; AND AUTHORIZING THE APPROPRIATION AND EXPENDITURE OF \$20,950 FROM CIP 29-570.0 FOR CONSTRUCTION OF BACKSTOPS AT THE JOINT USE SITE.

WHEREAS, the Adobe Bluffs Elementary School and the Adobe Bluffs Neighborhood Park is located in the Rancho Peñasquitos community; and

WHEREAS, a joint use agreement between the City of San Diego and the Poway Unified School District for the use of the turfed fields at Adobe Bluffs Elementary School and Adobe Bluffs Neighborhood Park would contribute to meeting the recreational needs of the Rancho Peñasquitos community; and

WHEREAS, the Board of the Poway Unified School District approved the Agreement for the Joint Use, Operation, and Maintenance of Turfed Fields, Parking Lot, and Restroom at Adobe Bluffs Elementary School and Adobe Bluffs Park at its meeting on December 10, 2001, and authorized the Assistant Superintendent of Business Support Services to sign the Joint Use Agreement for the Board; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the City Manager is authorized and empowered to execute, for and on behalf of the City, an Agreement for the Joint Use, Operation, and Maintenance of Turfed Fields, Parking Lot, and Restroom at Adobe Bluffs Elementary School and Adobe Bluffs Park [Joint Use Agreement] with the Poway Unified School District of Poway, California, for the joint use, operation, and maintenance of turfed multi-purpose fields, parking lot and restroom, and the construction of two backstops at Adobe Bluffs Elementary School and Adobe Bluffs Park, under the terms and conditions set forth in the Joint Use Agreement on file in the Office of the City Clerk as Document No. OO-

Section 2. That the Auditor and Comptroller is authorized to amend the Fiscal Year 2002 Capital Improvements Projects Budget by adding CIP No. 29-570.0, Adobe Bluffs Joint Use Area Improvements, in the amount of \$20,950 in Fund No. 11140, Peñasquitos North Park Fee District.

Section 3. That the appropriation and expenditure of an amount not to exceed \$20,950 from CIP No. 29-570.0, Adobe Bluffs Joint Use Area Improvements, is authorized, solely and exclusively, for the purpose of constructing backstops, in accordance with terms and conditions of the Joint Use Agreement.

Section 4. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 5. That this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
