

ORDINANCE NUMBER O-19125 (NEW SERIES)

ADOPTED ON NOV 26 2002

AN ORDINANCE AMENDING ORDINANCE O-19083 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 2002-2003 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-19083, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE NON-PERSONNEL APPROPRIATION IN CITY WIDE PROGRAM EXPENDITURES, DEPARTMENT (601), IN GENERAL FUND 100, FOR THE PURPOSE OF FUNDING VENDOR PAYMENTS FOR THE RED LIGHT PHOTO ENFORCEMENT PROGRAM FROM UNBUDGETED RED LIGHT PHOTO ENFORCEMENT PROGRAM REVENUES.

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. Ordinance O-19083 (New Series), as amended, entitled, "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 2002-2003 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" be and the same is hereby amended by amending Document No. OO-19083, as amended and adopted therein, to increase the Non-Personnel Appropriation in Citywide Program Expenditures, Department (601), in General Fund 100, by \$650,000 for the purpose of funding vendor payments for the Red Light Photo Enforcement Program from unbudgeted Red Light Photo Enforcement Program revenues.

Section 2. That the City Auditor And Comptroller is hereby authorized to complete the financial transactions specified in City Manager's Report No. 02-203.

Section 3. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 4. That this ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of the City of San Diego.
