AN ORDINANCE AMENDING CHAPTER 6, ARTICLE 7, DIVISION 2, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 67.0222 RELATING TO REGULATION OF WATER SYSTEM - ESTIMATION OF WATER BILLS.

WHEREAS, the City of San Diego Water Department currently employs a bi-monthly meter-reading and billing schedule; and

WHEREAS, on April 30, 2002, the San Diego City Council directed the Water Department to implement a monthly billing schedule; and

WHEREAS, the existing bi-monthly meter-reading schedule provides the best use of the City's resources; and

WHEREAS, the periodic estimation of water bills is necessary to implement a monthly billing schedule employing a bi-monthly meter-reading schedule; and

WHEREAS, Municipal Code section 67.0222 currently allows for the estimation of water bills only under limited circumstances; and

WHEREAS, written estimation procedures approved by the City Manager shall assure the accuracy of water bill estimations; and

WHEREAS, the City Council now intends to allow for the periodic estimation of water bills pursuant to such written procedures; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That Chapter 6, Article 7, Division 2, of the San Diego Municipal Code is hereby amended by amending Section 67.0222, to read as follows:

§67.0222 Regulation of Water System - Estimation of Water Bills

The Department has the authority to estimate water bills pursuant to the Department's written procedures approved by the City Manager.

Section 2. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
