BE IT FURTHER RESOLVED, by the Council, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a final settlement agreement with Golden Turner in the amount of \$2,800,000, on file in the office of the City Clerk as Document No. RR- $\frac{296046}{}$

BE IT FURTHER RESOLVED, that the Council hereby accepts and authorizes the increased appropriation of \$900,000 from Convention Center Expansion Fund No. 102212 and \$1,225,016 from Public Liability Reserve Fund No. 81140 to Convention Center Expansion CIP No. 370100.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$2,800,000 from Convention Center Expansion CIP No. 370100 for the payment of the final settlement agreement with Golden Turner, is hereby Authorized provided that the City Auditor first furnishes a certificate demonstrating that the funds necessary for such expenditures are, or will be, on deposit in the City Treasury.
