A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING REIMBURSEMENT FOR COURSE IMPROVEMENTS AT TORREY PINES GOLF COURSE.

WHEREAS, on June 12, 2001, City Council adopted Resolution No. 294994 authorizing the City Manager to execute an agreement with the Century Club of San Diego to design and reconstruct eighteen greens and one practice green on the South Course of the Torrey Pines Golf Course and agreeing to reimburse the Century Club or its assignee \$950,000 after completion of the improvements if funds are allocated for greens reconstruction at any time through Fiscal Year 2008 [the Improvements Agreement]; and

WHEREAS, reconstruction of the greens was completed on November 1, 2001; and WHEREAS, pursuant to an agreement between the Century Club and the Friends of Torrey Pines, LLC, the Century Club has assigned all of its rights under the Improvements Agreement to the Friends of Torrey Pines, LLC;

WHEREAS, funds are currently available to make the reimbursement provided for in the Improvements Agreement and the City Council desires to make such reimbursement at this time; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes the City Auditor and Comptroller to expend \$950,000 to reimburse the Friends of Torrey Pines, LLC, from CIP 25-004.0, Torrey Pines Golf Course - Reconstruction of 19 Greens (Fund No. 41402), pursuant to the Agreement for Improvements on the South Course at Torrey Pines Golf Course (Document No. RR-294994, filed in the Office of the City Clerk on June 12, 2001), for reimbursement of City's portion of costs for the construction of course improvements on Torrey Pines South Golf Course.
