A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A SECOND AMENDMENT TO AGREEMENT WITH WIMMER YAMADA AND CAUGHEY FOR THE MISSION TRAILS REGIONAL PARK EQUESTRIAN STAGING AREA; AUTHORIZING THE APPROPRIATION AND EXPENDITURE OF \$156,107 FOR USE ON THE PROJECT.

WHEREAS, the Mission Trails Regional Park Equestrian Center Project [the Project] will provide a 12 acre area in the northeast corner of the Park for equestrian and other uses including a multi-purpose building for rangers and visitors, a parking lot for equestrian users, picnic areas, a parking lot for hiking and biking users, and multi-purpose arenas; and

WHEREAS, on April 26, 1999, the City of San Diego entered into a consultant agreement for professional services [the Agreement] with the firm of Wimmer Yamada and Caughey [Consultant], a copy of which is on file in the Office of the City Clerk as Document No. C-09351, for preparation of a General Development Plan for the Project; and

WHEREAS, on January 23, 2001, the City Manager approved the First Amendment to the Agreement, a copy of which is on file in the Office of the City Clerk as Document No. C-10580, to revise the scope of services for the purpose of providing additional studies required by the Site Development Permit and for environmental review; and

WHEREAS, the Consultant has completed the work to be performed under the Agreement and the First Amendment to the Agreement and the City would now like to

revise the scope of services to provide the construction documents and related professional services for the Project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Council approves and authorizes the City Manager to execute, for and on behalf of the City, a Second Amendment to Agreement with Wimmer Yamada and Coughey for the construction documents and related professional services for the Mission Trails Regional Park Equestrian Center Project, under the terms and conditions set forth in the Second Amendment to Agreement on file in the Office of the City Clerk as Document No. RR- 296067
- 2. That the Council authorizes the City Auditor and Comptroller to expend an amount not to exceed \$156,107 from CIP No. 20-010.0, Annual Allocation Resource Based Open Parks, Mission Trails Regional Park East Fortuna Equestrian Staging Area, (Sublet CIP No.201013), solely and exclusively for the purpose of providing funds for the above Project.
