## RESOLUTION NUMBER R- 296153

## ADOPTED ON MAR 1 8 2002

WHEREAS, an expenditure in the amount of \$197,000 was previously authorized by the Council of the City of San Diego by Resolution R-292662, adopted January 18, 2000 from Fund No. 38090 for CIP No. 29-447.0, Lake Murray Comfort Station, for the purpose of constructing the Lake Murray Comfort Station project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That all bids theretofore received on October 3, 2001, pursuant to publication of notice calling for bids on the construction of Lake Murray Comfort Station, are hereby rejected.
- 2. That the amended plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for the construction of Lake Murray Comfort Station, filed in the office of the City Clerk of the City of San Diego, California, on MAR 1 8 2002, and bearing official Document No. W.O. 294470, be, and the same are hereby approved.
- 3. That the Contracts Services Division of the City of San Diego, be and is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the amended plans and specifications hereinabove referred to.
- 4. That the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for the construction of Lake Murray Comfort Station, San Diego, California.

5. That the transfer of an amount not to exceed \$23,200 from the Snack Bar Fund No. 10365, Org. No. 2444, Dept. No. 10365; an amount not to exceed \$26,400 from Architect Fee Fund No. 10365, Org. No. 2444, Dept. No. 10365; an amount not to exceed \$125,000 from Navajo DIF Fund 79506; an amount not to exceed \$125,000 from the Mayor's Infrastructure Funds, Fund No. 10529, Org. No. 9000, and an amount not to exceed \$50,000 from Park and Recreation Matching Funds, Dept. No. 30244, Org. No. 105, CIP No. 20-013.0 to CIP No. 29-447.0, Lake Murray Comfort Station, is hereby authorized.

6. That the increase of an amount not to exceed \$349,600 to FY 2002 Capital Improvement Program budget for CIP 29-447.0, is hereby authorized.

7. That the expenditure of an amount not to exceed \$349,600 to augment previously authorized funds from CIP No. 29-447.0, Lake Murray Comfort Station, for the construction of Lake Murray Comfort Station, is hereby authorized solely and exclusively for providing funds for said project and related costs.

8. That the Auditor and Comptroller, upon advice from the administering department, is hereby authorized to transfer excess budgeted funds, if any, to the appropriate reserves.
