- 3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for the Replacement of Tree Root Damaged Sidewalk and Curb/Gutter City Wide Group C-20.
- 4. That the expenditure of an amount not to exceed \$700,000 from Street Division's Operating Fund 10440, is hereby authorized solely and exclusively for the purpose of providing funds for said project and related costs; provided that the City Auditor and Comptroller first furnishes a certificate demonstrating that the funds necessary for such expenditure are, or will be, on deposit with the City Treasurer.

5. That the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
