- 2. That a \$1,740,000 increase to C.I.P. 29-546.0 Torrey Highlands Neighborhood Park North in Fund 39069, Torrey Highlands Planned Urbanizing Development Impact Fees is authorized;
- 3. That the City Manager is hereby authorized to purchase the needed property rights;
- 4. That the appropriation and expenditure of an amount not to exceed \$1,740,000 from C.IP. No. 29-546.0, Fund No. 39069, for the acquisition of property rights, reimbursement of cost of the site improvements, labor, title, escrow and miscellaneous costs is authorized; and

5. That it is stated for the record that the final Mitigated Negative Declaration has been reviewed and considered prior to approving the project and the City Clerk is directed to file a Notice of Determination.
