

RESOLUTION NUMBER R- 296166

ADOPTED ON MAR 18 2002

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Auditor and Comptroller is hereby authorized to open Fund No. 78174 for the purpose of depositing Public Utilities Commission Case 8209 Utility Undergrounding Allocation Funds for the Archaeological Monitoring for Silverado Street from Eads Avenue to Ivanhoe Avenue; the 900 block of Scott Street; 25th Street from Market Street to Commercial Avenue; CCDC Area 3 Phase 1, Job 2; "B" Street (19th Street to 30th Street); Saturn Boulevard from Coronado Avenue to Leon Street Underground Utility Districts.

2. That the City Treasurer is hereby authorized to receive these funds from the San Diego Gas & Electric Company.


3. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, Archaeological Monitoring Agreement(s) for the Silverado Street from Eads Avenue to Ivanhoe Avenue; the 900 block of Scott Street; 25th Street from Market Street to Commercial Avenue; CCDC Area 3 Phase 1, Job 2; "B" Street (19th Street to 30th Street); Saturn Boulevard from Coronado Avenue to Leon Street Underground Utility Districts, in an amount not to exceed \$150,000, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

That the expenditure of an amount not to exceed \$150,000 from Fund No. 78174, is hereby authorized, solely and exclusively, for the purpose of archaeological monitoring for Silverado Street from Eads Avenue to Ivanhoe Avenue; the 900 block of Scott Street; 25th Street from Market Street to Commercial Avenue; CCDC Area 3 Phase 1, Job 2; "B" Street (19th Street to 30th Street); Saturn Boulevard from Coronado Avenue to Leon Street Underground Utility Districts.

5. That the City Auditor and Comptroller is hereby authorized to return to San Diego Gas & Electric Company any undisbursed funds upon written notice from San Diego Gas & Electric Company to the City that all electric service conversions for the Silverado Street from Eads Avenue to Ivanhoe Avenue; the 900 block of Scott Street; 25th Street from Market Street to Commercial Avenue; CCDC Area 3 Phase 1, Job 2; "B" Street (19th Street to 30th Street); Saturn Boulevard from Coronado Avenue to Leon Street Underground Utility Districts have been completed.
