BE IT FURTHER RESOLVED, that the City Council accepts on behalf of the City of San Diego, the building restricted easement over, upon or across all of Lot "A" as shown on this map within this subdivision and designated as "Building Restricted Easement," as granted and shown on the MAP and subject to the conditions set forth on the MAP.

BE IT FURTHER RESOLVED, that the City Council accepts on behalf of the City of San Diego, the easement with the right of ingress and egress for the construction and maintenance of water facilities and drainage facilities over, under, upon and across Lots 1, 2, 3, 4, 6 and "A", as shown on this map within this subdivision and designated as "Water Easement" and "Drainage Easement," as granted and shown on the MAP and subject to the conditions set forth on the MAP.

BE IT FURTHER RESOLVED, that the City Clerk is authorized and directed to endorse upon the MAP, as and for the act of the Council, and that the Council has approved the MAP on behalf of the public as stated in this resolution.
