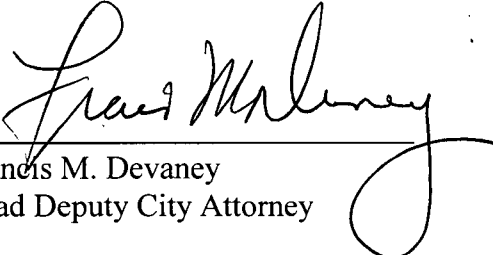
RESOLUTION NUMBER R- 296325
