- 1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for the Replacement of Sidewalk and Curb/Gutter City Wide Group C-22, filed in the office of the City Clerk of the City of San Diego, California, on APR 1 5 2002, and bearing official Document No.

 W.O. 590000 be and the same are hereby approved.
- 2. That the Contract Services Division of the City of San Diego is authorized and directed to proceed to publish notice to contractors calling for bids for the work described in paragraph number 1, in accordance with the plans and specifications referred to in that paragraph.
- 3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for the Replacement of Sidewalk and Curb/Gutter City Wide Group C-22.
- 4. That the City Auditor and Comptroller is authorized, upon direction of the City Manager, to reallocate the funding sources for TransNet funds between TransNet Cash and Commercial Paper funded projects as may be appropriate to maximize the use of TransNet Cash and minimize the use of Commercial Paper funding for CIP 59-002.0.
- 5. That the expenditure of an amount not to exceed \$486,000 from Fund 30300, CIP 59-002.0, Annual Allocation to be funded by TransNet fund 30300, is hereby authorized solely and exclusively for the purpose of providing funds for said project and related costs,

provided that the City Auditor and Comptroller first furnishes a certificate demonstrating that the funds necessary for such expenditure are, or will be, on deposit with the City Treasurer.

6. That the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
