BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$166,245 from Fund No. 41500, CIP 70-954.0, North City Reclamation System (Greystone Torrey Highlands), is hereby authorized, solely and exclusively to provide funds for the above agreement and related in-house engineering costs, provided that the City Auditor and Comptroller first furnishes a certificate certifying that the funds necessary for expenditure under established contract funding phases are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the City Auditor is authorized to transfer excess budgeted funds, if any, to the appropriate reserves on advice of the administering department.
