A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE ALLOCATION AND EXPENDITURE OF FUNDS FOR PLAYGROUND UPGRADES AT PRINCESS DEL CERRO NEIGHBORHOOD PARK; AND AMENDING THE CIP BUDGET.

WHEREAS, pursuant to Resolution No. R-293698 adopted by City Council on August 15, 2000, the City applied for and secured grant funds for park projects from the State of California under the Safe Neighborhood Parks, Clean Water, Clean Air and Coastal Protection Act of 2000 [Park Bond Act], including playground upgrades in each Council District; and

WHEREAS, the City desires to upgrade the existing children's play area at Princess Del Cerro Neighborhood Park to comply with disability access and safety laws; and

WHEREAS, the total cost of the upgrades at Princess Del Cerro Neighborhood Park is \$230,000 and funds are available as follows: \$204,000 from 2000 Park Bond Per Capita Funds, Fund No. 38178; and \$26,000 from Park and Recreation Matching Funds, Fund No. 10365; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That, pending receipt of a fully executed grant agreement, the Council authorizes the City Auditor and Controller to amend the Fiscal Year 2002 Capital Improvements Program Budget to add CIP No. 29-556.0, Princess Del Cerro Neighborhood Park - Tot Lot Upgrade, in the amount of \$230,000, as follows: \$204,000 from 2000 Park Bond Per Capita Funds, Fund No. 38178; and \$26,000 from Park and Recreation Matching Funds, Fund No. 10365.

2. That, pending receipt of a fully executed grant agreement, the Council appropriates and authorizes the City Auditor and Comptroller to expend \$230,000 from CIP No. 29-556.0, Princess Del Cerro Neighborhood Park - Tot Lot Upgrade (\$204,000 from 2000 Park Bond Per Capita Funding, Fund No. 38178, and \$26,000 from Park and Recreation Matching Funds, Fund No. 10365).
