A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE APPLICATION FOR AND EXPENDITURE OF FEDERAL GRANT FUNDS FOR PLAYGROUND UPGRADES AT KEILLER NEIGHBORHOOD PARK

WHEREAS, the Federal Government has authorized \$28.836 million in grant funding for the rehabilitation of urban recreational parks for the National Park Service's Fiscal Year 2002

Urban Park and Recreation Recovery (UPARR) Grant Program; and

WHEREAS, the City desires to upgrade the existing children's play area at Keiller Neighborhood Park in the Skyline Community to upgrade the existing play equipment and comply with disability access and safety laws;

WHEREAS, upgrading the children's playground at Keiller Neighborhood Park meets the following criteria for the UPARR Grant Program: (1) the children's playground needs rehabilitation; (2) the park serves neighborhood recreational needs; (3) the park serves low to moderate income residents who are ethnically diverse and include persons with physical or mental disabilities; and (4) there is a lack of local funds to complete the project; and

WHEREAS, the City has available the required matching funds; and

WHEREAS, if obtained, the grant funds in the amount of \$153,860 will be applied toward the total project cost of \$250,110; the balance of \$96,250 will be met through Park and

Recreation Department Matching Funds (\$60,000) and Park and Recreation Building Permit Fees (\$36,250); NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Council authorizes the City Manager or designee to apply to the National Park Service's Urban Park and Recreation Recovery (UPARR) Grant Program for a grant to upgrade the Keiller Neighborhood Park children's playground.
- 2. That the Council authorizes the City Manager or designee to take all necessary actions to secure grant funds from the UPARR Grant Program for playground upgrades at the Keiller Neighborhood Park.
- That, if the grant funds are secured, the Council appropriates and authorizes the City Manager to expend the local match and grant funds in accordance with the terms and conditions set forth in the grant funding agreement.
- 4. That the Council authorizes the City Auditor and Comptroller, upon receipt of a fully executed grant agreement, to establish a special interest-bearing fund for the grant funds.
- 5. That the Council authorizes the City Auditor and Comptroller, upon receipt of a fully executed grant agreement, to amend the Fiscal Year 2002 Capital Improvements Program Budget to add CIP 29-592.0, Keiller Neighborhood Park Children's Playground Improvements, in the amount of \$250,110.
- 6. That upon receipt of a fully executed grant agreement, the Council authorizes the City Auditor and Comptroller to allocate \$60,000 from CIP 20-013.0, Park and Recreation Grant Match Funding, to CIP 29-592.0, Keiller Neighborhood Park Children's Playground Improvements.

- 7. That, if the grant funds are secured, the Council authorizes the City Auditor and Comptroller to allocate \$36,250 from Park and Recreation Building Fees District, Fund No. 15000, to CIP No.29-592.0, Keiller Neighborhood Park Children's Playground Improvements.
- 8. That, if the grant funds are secured, the Council appropriates and authorizes the City Auditor and Comptroller to expend \$250,110 from CIP No. 29-592.0 for the playground and other improvements at Keiller Neighborhood Park as follows: \$36,250 from Park and Recreation Building Fees District (Fund No. 15000), \$60,000 from Park and Recreation Grant Match Funding (Fund No. 630221), and \$153,860 from UPARR grant funds (contingent upon receipt of a fully executed grant agreement).
