- 1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation, and other expense necessary or incidental for the General Requirement Contract [Contract], filed in the office of the City Clerk of the City of San Diego, California, on and bearing official Document No. Oo 2003 A, as advertised by the Contract Services Division of the City of San Diego, be and the same are hereby approved.
- 2. That the Contract Services Division is authorized and directed to proceed to publish notice to contractors calling for bids for the Contract, in accordance with the plans and specifications referred to in Paragraph 1.
- 3. That the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for the Contract.
- 4. That the expenditure of an amount not to exceed \$500,000 from Water Fund 41500, and an amount not to exceed \$3,500,000 from Sewer Fund 41506, is hereby authorized solely and exclusively for the purpose of providing funds for the Contract and related costs, provided that the City Auditor and Comptroller first furnishes a certificate demonstrating that the funds necessary for such expenditure are or will be on deposit with the City Treasurer.

5. That the City Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
