A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AN AGREEMENT BETWEEN THE CITY AND THE MIRA MESA RECREATION COUNCIL.

WHEREAS, the Mira Mesa Community Park [Park] has been identified as needing lighting upgrades for the Park's ballfields numbers one and two, and the multi-purpose field; and

WHEREAS, the City desires to upgrade the lighting at the Park by relocating light poles and fixtures to the Park from Lopez Ridge Park [Project]; and

WHEREAS, Councilmember Brian Maienschein desires to provide \$14,000 from District Five's Fiscal Year 2002 Infrastructure Improvement Fund to the Mira Mesa Recreation Council, a nonprofit Association [MMRC], for the purpose of assisting the Project; and

WHEREAS, after receiving the \$14,000 from the City, MMRC will combine it with \$20,000 from its funds, and will forward the total amount of \$34,000 to the City's Park and Recreation Matching Funds Program, for the purpose of assisting the Project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Agreement between the City and MMRC regarding the transfer of funds between the City and MMRC for the purpose of assisting the lighting upgrade at Mira Mesa Community Park, is approved.

- 2. That the transfer of \$14,000 to MMRC from Fund No. 10529, Council District Five Infrastructure Improvement Fund for the purpose of assisting the lighting upgrade at Mira Mesa Community Park, is approved.
- 3. That the total amount that the City will provide MMRC under the terms of the Agreement shall not exceed \$14,000 from Fund No. 10529, Council District Five Infrastructure Improvement Fund.
- 4. That the City Manager, or designee, is authorized to execute, on behalf of the City, the Agreement between the City and MMRC. A copy of the Agreement, when executed, shall be placed on file in the Office of the City Clerk as Document No. RR-296550.
