A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ACCEPTING FUNDS FROM THE MIRA MESA RECREATION COUNCIL; AUTHORIZING AN AMENDMENT TO THE CAPITAL IMPROVEMENTS PROJECT BUDGET; AND AUTHORIZING THE EXPENDITURE OF FUNDS FOR THE MIRA MESA COMMUNITY PARK SPORTS FIELD LIGHTING UPGRADE.

WHEREAS, the Mira Mesa Community Park [Park] has been identified as needing lighting upgrades for the Park's ballfields numbers one and two, and the multi-purpose field; and

WHEREAS, the City desires to upgrade the lighting at the Park by relocating light poles and fixtures to the Park from Lopez Ridge Park [Project]; and

WHEREAS, the Mira Mesa Recreation Council [MMRC] received \$14,000 from the City for the purpose of funding the Project; and

WHEREAS, the MMRC wishes to provide a total of \$34,000 to the City's Park and Recreation Matching Fund (\$14,000 previously received by MMRC from the City and \$20,000 from other MMRC funds); NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the Council accepts funds from MMRC in the amount of \$14,000 to Fund No.
10365, Park and Recreation Matching Funds, for the purpose of upgrading lighting at the Mira
Mesa Community Park.

- 2. That the Council accepts the generous donation of \$20,000 from MMRC to Fund No. 10365, Park and Recreation Matching Funds, for the purpose of upgrading lighting at the Mira Mesa Community Park.
- 3. That the Council authorizes amendment of the Fiscal Year 2002 Capital Improvements Program Budget by increasing CIP No. 29-593.0, Mira Mesa Community Park-Sports Field Lighting, in the amount of \$128,000, from the following funds:

Fund No. 10516, Mira Mesa Community Fund, in the amount of \$30,000;

Fund No. 10365, Park and Recreation Matching Funds, in the amount of \$64,000;

Fund No. 10365, Park and Recreation Matching Funds, in the amount of \$20,000, (from the Mira Mesa Recreation Council), and;

Fund No. 10365, Park and Recreation Matching Funds, in the amount of \$14,000, (from the Mira Mesa Recreation Council).

4. That the Council appropriates and authorizes the City Auditor and Comptroller to expend an amount not to exceed \$128,000 for CIP 29-593.0, Mira Mesa Community Park-Sports Field Lighting, from the following funds:

Fund No. 10516, Mira Mesa Community Fund, in the amount of \$30,000;

Fund No. 10365, Park and Recreation Matching Funds, in the amount of \$64,000;

Fund No. 10365, Park and Recreation Matching Funds, in the amount of \$20,000,

(from the Mira Mesa Recreation Council), and;

Fund No. 10365, Park and Recreation Matching Funds, in the amount of \$14,000, (from the Mira Mesa Recreation Council).

5. That these appropriations and authorization of expenditure of funds is contingent upon the Auditor and Comptroller certifying that funds are available.
