A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AMENDING THE CAPITAL IMPROVEMENTS PROJECT BUDGET AND AUTHORIZING THE EXPENDITURE OF FUNDS FOR BIRD PARK ARTISTIC UPGRADES CONSTRUCTION DOCUMENTS.

WHEREAS, Bird Park is located in the northeast corner of Balboa Park, on the corner of Balboa Park on 28th and Upas Streets; and

WHEREAS, the City desires to upgrade Bird Park by adding several improvements, including the addition of an entrance arbor, mosaic picnic tables, a bird's eye gazebo, a "beak" patio, the game of the golden goose, a cobblestone foot, and enhanced landscaping that will attract birds; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Council authorizes amendment of the Fiscal Year 2002 Capital Improvements Program Budget by adding CIP 21-861.0, Bird Park Artistic Upgrades Construction Documents, in the amount of \$30,000.

2. That the Council appropriates, and authorizes the City Auditor and Comptroller to expend \$30,000 for CIP 21-861.0, for Bird Park Artistic Upgrades Construction Documents, from Park and Recreation Department Matching Funds, fund number 10365.
