BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$25,000 from CIP No. 29-662.0, Southcrest Community Park Tot Lot Upgrade to augment previously authorized expenditures, and authorizing the Auditor and Comptroller, upon advice from the Engineering and Capital Projects Department to transfer excess budgeted funds, if any, the appropriate reserves.
