- (c) the vacation is not inconsistent with the General Plan, an approved Community Plan or Local Coastal Program; and
- (d) the purpose for which the easement was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That a portion of the sewer and drainage easement located within Lot 6 of Map No. 13125, as more particularly described in the legal description, attached hereto as Exhibit "A", and as shown on Drawing No. 19233-B, attached hereto as Exhibit "B", is ordered vacated.

2. That the City Clerk shall then cause a certified copy of this resolution, with Exhibits "A" and "B", attested by him under seal, to be recorded in the Office of the County Recorder.
