BE IT RESOLVED, by the Council of The City of San Diego, as follows:

SAN DEGO, CALE.

- 1. That the alley as more particularly shown on Exhibit "B," and on Drawing 19602-B, on file in the office of the City Clerk as Document No. RR-296616, which is by this reference incorporated herein and made a part hereof, is ordered vacated.
- 2. That this Resolution shall not become effective unless and until Planned Development Permit No. 5291 is approved by the Council.
- 3. That the City Clerk shall cause a certified copy of this resolution, with Exhibit "B" and Drawing No. 19602-B, attested by him under seal, to be recorded in the office of the County Recorder.
