

RESOLUTION NUMBER R- 296634

ADOPTED ON JUN 04 2002


BE IT RESOLVED, by the Council of the City of San Diego, that in accordance with the 2002 Appropriation Ordinance, the City Auditor and Comptroller is authorized and directed to amend the Fiscal Year 2002 Capital Improvement Program budget to add CIP 32-025.0, Ridgehaven Building Photovoltaic Project.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$580,700 within Fund No. 41200, from Fund Balance 41200, to CIP 32-025.0, Ridgehaven Building Photovoltaic Project.

BE IT FURTHER RESOLVED, that the City Manager is authorized and empowered to execute, for and on behalf of the City, a design/build agreement with the Powerlight Corporation, to design and install a 64.8 kilowatt photovoltaic energy generation system on the Ridgehaven Green Building Facility in an amount not to exceed \$566,727 and under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document RR- 296634.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$580,700 from Fund No. 41200, CIP 32-025.0, Ridgehaven Building Photovoltaic Project, is authorized, solely and exclusively to provide funds for the above agreement and project contingency.
