A RESOLUTION APPROVING THE FIRST AMENDMENT TO CABRILLO PLAZA LEASE AGREEMENT FOR THE POLICE DEPARTMENT PROFESSIONAL STANDARDS UNIT AT 3990 OLD TOWN AVENUE.

WHEREAS, the Police Department's Professional Standards Unit's current lease of 2,197 square feet of office space at 3990 Old Town Avenue, Suite 205 C, San Diego, California, expires on April 30, 2002; and

WHEREAS, the City Manager has negotiated a First Amendment to the lease agreement with Dolphinshire L.P., to continue the City's leasehold for another five-year term, commencing on May 1, 2002, and expiring on April 30, 2007; and

WHEREAS, the initial rental rate will be \$3,075 per month (\$1.40 per square foot) with five cent (\$0.05) annual increases, plus utilities. A rental survey of similar properties confirms that the proposed rental rate is below market for the area; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager is authorized to execute, for and on behalf of the City of San Diego, the First Amendment to Cabrillo Plaza Lease Agreement with Dolphinshire L.P., a California limited partnership, commencing on May 1, 2002, and expiring on April 30, 2007, at an initial monthly rent of \$3,075, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR-296645.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to expend an amount not to exceed \$6,458 from the General Fund - Police Department Budget, for lease costs from May 1, 2002, to June 30, 2002.
