## **RESOLUTION NUMBER R-296657**

## ADOPTED ON JUNE 11, 2002

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ESTABLISHING A ONE YEAR TRIAL OFF-LEASH AREA FOR DOGS AT DOYLE COMMUNITY PARK.

WHEREAS, on May 30, 1972, the City Council approved by Ordinance No. 10843 the first off-leash areas for dogs in San Diego at Fiesta Island and Dog Beach; and

WHEREAS, San Diego Municipal Code section 63.0102 authorizes the Park and Recreation Director [Director] to designate dog exercise and training [Off-Leash] areas, in Cityowned parks; and

WHEREAS, in 1993, the Director authorized a trial Off-Leash area at Grape Street Park in Balboa Park; on April 12, 1999, City Council approved by Resolution No. R-291472 amended off-leash area boundaries and hours at Grape Street Park; and in 2000, the Director authorized continuing the boundaries and hours of the trial Off-Leash area at Grape Street Park; and

WHEREAS, in 1996, the Director authorized trial Off-Leash areas at Nates Point and Morley Field behind the tennis courts, both in Balboa Park; and in 2001, the Director authorized trial Off-Leash areas at Maddox Neighborhood Park and Cadman Community Park; and

WHEREAS, there continues to be an unmet recreational demand by the public for areas where dogs can legally be off-leash; and

WHEREAS, the City Council recognizes that off-leash dog activity to be a valid recreational use; and

WHEREAS, areas authorized to be off-leash areas benefit the residents of San Diego; and WHEREAS, the Council desires to establish a trial Off-Leash area at Doyle Community Park; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Council hereby establishes, for a period of one year, a trial off-leash area for dogs at Doyle Community Park, in University City.
- 2. That the Off-Leash area is described as approximately 0.90 acres in the eastern portion of the unimproved area of Doyle Community Park, between the ballfield and Cargill Street, as indicated in Exhibit A (Map of Doyle Community Park), and will include a perimeter fence and separation fence between the two sub-areas.
- 3. That the Council directs the City Manager, or designee, to implement the Off-Leash area at Doyle Community Park.
- 4. That the Council authorizes amendment of the Fiscal Year 2002 Capital

  Improvements Program Budget by adding CIP No. 29-601.0, Doyle Community Park Off Leash

  Area.
- 5. That the Council authorizes amendment of the Fiscal Year 2002 Capital Improvements Budget by increasing CIP No. 29-601.0, Doyle Community Park Off Leash Area, in the amount of \$11,315 from Fund No. 11480, University Park Service District Fees.

6. That the Council appropriates and authorizes the City Auditor and Comptroller to expend an amount not to exceed \$11,315 from CIP No. 29-601.0, Doyle Community Park Off Leash Area, from Fund No. 11480, University Park Service District Fees.


