BE IT FURTHER RESOLVED that the City Auditor and Comptroller is authorized to accept and appropriate an additional \$140,100 of Congestion Mitigation and Air Quality Funds (Fund No. 38676) for design and construction of Miramar Road Traffic Signal Interconnect.

BE IT FURTHER RESOLVED that the expenditure of additional funds of an amount not to exceed \$140,100 from CIP No. 62-306.0 is authorized for the Miramar Road Traffic Signal Interconnect, contingent upon receipt of a fully executed Congestion Mitigation and Air Quality Fund Program Supplement and provided that the City Auditor first furnishes a certificate demonstrating that the funds necessary for such expenditures are, or will be, on deposit in the City Treasury.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is authorized, to retain excess monies, if any, in CIP 62-306.0.
