BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Agreement between the City and Van Dyke, LLP regarding the Master Plan revision for Sunset Cliffs Natural Park is approved.

- That the total amount of the Agreement shall not exceed \$33,400.00 from CIP
 No. 28-005.0, Fund No. 63034, Sunset Cliffs Shoreline Park Improvements, Sunset Cliffs Natural
 Park.
- 3. That the City Manager, or designee, is authorized to execute, on behalf of the City, the Agreement between the City and Van Dyke, LLP. A copy of the Agreement, when executed, shall be placed on file in the Office of the City Clerk as Document No. RR- 296768.
