

RESOLUTION NUMBER R- 296772

ADOPTED ON JUL 08 2002

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO FINDING THAT ALL APPLICABLE PROCEDURES WERE FOLLOWED IN THE ELECTION OF THE PROJECT AREA COMMITTEE FOR THE PROPOSED CROSSROADS REDEVELOPMENT PROJECT AREA.

WHEREAS, the City Council of the City of San Diego [Council] has approved a proposed Redevelopment Plan and Preliminary Report for the proposed Crossroads Redevelopment Project [Project]; and

WHEREAS, the City Council is required to complete the actions prescribed by sections 33354.6 of the California Community Redevelopment Law, Health and Safety Code section 33000 *et. seq.* [CRL]; and

WHEREAS, in connection with the proposed Redevelopment Plan, the Council approved the "Procedure for Formation and Election of a Project Area Committee" [Procedures] for the Crossroads Redevelopment Project Area calling upon any or all residential owner-occupants, residential tenants, existing community organizations and business owners within Project Area to form a Project Area Committee [PAC]; and

WHEREAS, a public meeting was held on April 24, 2002, to explain the establishment of, functions of, and opportunity to serve on the PAC; and

WHEREAS, the election of a representative PAC was held on May 15, 2002, and a subsequent run-off election was held on May 29, 2002; and

WHEREAS, section 33385(d) of the California Community Redevelopment Law, Health and Safety Code sections 33000, *et seq.*, [CRL], provides that a challenge to the PAC election or the electoral process followed in connection with the PAC election, must be filed within the Council no more than 15 calendar days after the PAC election and further provides that the Council shall consider all challenges so filed and determine the validity of those challenges within 30 days following the PAC election; and

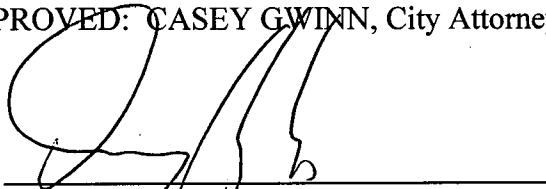
WHEREAS, two challenges to the election procedures were filed in a timely manner and those two challenges have been determined to be without merit; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The two challenges to the election of the PAC have been reviewed and determined to be without merit.
2. All of the "Procedures for Formation and Election of a Project Area Committee" which were approved by the City Council on April 2, 2002 were followed in connection with the election of the Project Area Committee which was held on May 15, 2002 and in connection with the Run-Off election which was held on May 29, 2002.
