WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of public street easements by City Council resolution where the easement is no longer required; and

WHEREAS, the adjacent property owners, and the State of California, have requested the vacation of a portion of Rosecrans Street to facilitate development of the site as more particularly described in the Agreement for Street Vacations and Construction of Public Improvements between the City of San Diego and the State of California; and

WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the street easement either for the public street system, for which the right-of-way was originally acquired, or for any other public use of a like nature that can be anticipated in that the right-of-way is not needed for public street, bikeway, or open space purposes;
 - (b) the public will benefit from the vacation through improved utilization of land;
- (c) the vacation is not inconsistent with the General Plan or an approved Community Plan; and
- (d) the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the portion of Rosecrans Street, as more particularly shown on Drawing No. 19704-B, attached as Exhibit "C", and as described in the legal description, attached as Exhibit "D", is ordered vacated.
- 2. That this resolution shall not become effective unless and until the Agreement for Street Vacations and Construction of Public Improvements between the City of San Diego and the State of California, on file in the Office of the City Clerk as Document No. RR-296780 is approved by the Council.
- 3. That the City Engineer shall advise the City Clerk of the completion of the conditions of the Agreement for Street Vacations and Construction of Public Improvements, and the City Clerk shall then cause a certified copy of this resolution, Exhibit "C", and Exhibit "D" attested by him under seal, to be recorded in the Office of the County Recorder.


