BE IT RESOLVED, by the Council of the City of San Diego as follows:

- 1. That the City Council hereby approves the conveyance of the real property described in Attachment 1 to the Redevelopment Agency for the purpose of developing the Metro Career Center and Metro Villas redevelopment project.
- 2. That the City Manager, or designee, is hereby authorized to execute any documents and take all actions necessary to carry out the conveyance of the real property.
