 - (b) the public will benefit from the vacation through improved utilization of land; and
- (c) the vacation is not inconsistent with the General Plan or an approved Community Plan; and
- (d) the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the portion of Road Survey 65 as more particularly shown on Exhibit "A" and on Drawing 19795-B, labeled Exhibit "B," which said exhibits are attached hereto and made a part hereof, be, and the same is hereby ordered, vacated.
- 2. That the City Clerk shall cause a certified copy of this resolution, Exhibit "A," and Exhibit "B" attested by him under seal, to be recorded in the Office of the County Recorder.
