WHEREAS, Lynn Swanson began her thirty-two-year career of public service with the City of San Diego in October of 1970 as a dispatcher in the Police Department where she met the

love of her life - her husband, John Swanson; and

WHEREAS, in 1981, Lynn continued her service to the public by transferring to the Street Division Department where she worked as a Litter Control Inspector; Lynn enjoyed the investigational aspect of her job so much that she joined the Civil Division of the City Attorney's Office in 1987 as an investigator, and within a year was promoted to Senior City Attorney Investigator; and

WHEREAS, Lynn will end her thirty-two year career at the City as a Senior City

Attorney Investigator, where her exceptional investigational skills greatly assisted the attorneys in winning hundreds of trials on behalf of the City; and

WHEREAS, together, John and Lynn have also raised five wonderful children and have been blessed with four grandchildren; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby recognize and appreciate John and Lynn Swanson by proclaiming August 15, 2002 to be "John and Lynn Swanson Day" in the City of San Diego, commemorating their combined sixty years of dedicated public service to the residents of San Diego.
