WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of public service easements by City Council resolution where the easement is no longer required; and

WHEREAS, the affected property owner has requested the vacation of a building restricted easement in Parcel 22 of Map No. 18504, to unencumber his property and facilitate its transfer to San Diego Gas and Electric, who intend to construct a substation that will serve the public; and

WHEREAS, San Diego Gas and Electric require the property owner to transfer the property free of all encumbrances; and

WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the building restricted easement either for which it was originally acquired, or for any other public use of a like nature that can be anticipated;
 - (b) the public will benefit from the vacation through improved utilization of land;
- (c) the vacation is not inconsistent with the General Plan, an approved Community Plan, or Local Coastal Program; and
- (d) the public service easement system for which the easement was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the building restricted easement located in Parcel 22 of Map No. 18504, as more particularly described in the legal description, attached hereto as Exhibit "A", and as shown on Drawing No. 19754-B, attached hereto as Exhibit "B", is ordered vacated.
- 2. That the City Engineer shall advise the City Clerk of the execution of the transfer deed by property owner to San Diego Gas and Electric, and the City Clerk shall then cause a certified copy of this resolution, with Exhibits "A" and "B", attested by him under seal, to be recorded in the Office of the County Recorder.


